- Name change validating legal documents required.
- Marital status validating legal documents required; must report change marriage/divorce within 30 days of event for health insurance coverage purposes.
- Addition of dependents; newborns must be reported within 30 days of birth for health insurance coverage.
- Address and telephone numbers •
- insurance beneficiary changes
- Other health insurance coverage cancellations or additional secondary coverage.
